# Year 2020 Association Activities Summary: A Year of Changes,

Due to President Scott Shrader's medical restrictions, his ability to publish a column for the quarterly newsletter is limited, so I will fill in until he fully recovers, including his quarterly column.

When this is published, December will be half over, thereby putting an end cap soon to what many consider to have been a completely disastrous 2020 calendar year. Without doubt, the year will go down as one of the most unique years in modern history. Things like the Covid-19 virus, the Antifa riots, the BLM racial wars, the remaking of the US history, the continued political turmoil within our national, a world depression on the economic front, international conflicts over land and sea domains and oh finally, who could ever forget about the November 3<sup>rd</sup> US Presidential election that is still occupying the daily news cycle. The summarization of all these events only makes the world dream of a simpler time.

But that is not what this column is about... it's time now to talk about some of the good things that are happening in the ENCOM Association's little portion of the world.

Given the new pandemic world we live in, adaption has become the new norm for most participants and this includes us at the ENCOM Association. One of the first things we did was convert our monthly Board meeting from a strictly verbal telephone conference call to the new standard by using ZOOM calls, which most of you know runs both audio and video interaction.

Once the Board decided to make the jump to Zoom and utilize the experience offered by Board Members like Lee Pryor, Edgar Montalvo and Shaun Murphy, we managed to work out a lot of the rough edges in the first few meetings. With all that, it didn't take long for the monthly meetings to start flowing somewhat smoother. From there it was a small jump to approve our Annual Dinner meeting to use the Zoom format too. The problem was just a question on how many people could/would attend the meeting versus the dinner format we normally hold in Darien, IL.

So Board decided to move into the 21<sup>st</sup> century (truly by accident) by using the October Board meeting as a large scale Zoom conference call. We did this by allowing for any ENCOM Association member to call in if they wanted. So in advance, we pushed out the board meeting information to ALL ENCOM ASSOCIATION members to see what kind of turn-out we would get.

Surprisingly, we managed to get about 25 people on that October call at 9 o'clock in the morning. This meeting also showed us that we had the capability to conduct a larger scale meeting without too much of an issue. This call also allowed us to get a better handle on how to use the software and what our capacity was. Our major concern was getting the necessary active interaction we needed, but without having members talk over one another when questions were asked. Plus, we had to maintain a strict controls on the time for those members who would be talking and how to maintain a smooth flow between elements of the meeting itself.

Our goal was to conduct a quick 15-minute board meeting in the half hour before the actual annual meeting, followed by a ONE HOUR Annual Meeting with a couple quick Q&A sessions, and then a 30-minute breakout session for members to voluntary interact with one another after the actual board meeting.

Plus we had a simple goal to conduct a couple quick interaction question polls to get some input from the participants on a couple key topics brought up before hand.

So moving forward, a group of eight hardy board members conducted at least seven weekly Tuesday night Zoom meetings in the months before the November 7<sup>th</sup> Annual Meeting to work out all the details

and script the meeting down to the last minute. Many THANKS need to go out to Robert Chevas, Michele Marsden, Gerry Meyer, Bob Mittelstaedt, Edgar Montalvo, Shaun Murphy, Lee Pryor, and Scott Shrader for the numerous hours they put in behind the scenes to help pull off what was a full-scale production for the Annual Meeting. Also special thanks go to Edgar, Lee and Shaun for their willingness to act as Technical Advisors as well to take phone calls from participant before and during the meeting to answer any Zoon related questions. Without all of their tireless efforts, the Annual meeting would have been nothing more than a quick HI, HELLO and GOODBYE!

Here is a quick summary of events for the Annual meeting:

- Edgar Montalvo, while serving as the Moderator, provided the ground rules for conducting the Zoom meeting for all participants. Also explained about the poll questions to be asked and how to direct any questions toward the speakers via the chat line capability within Zoom itself. He also briefly talked about the add-on breakout session at the end of the meeting.
- Chaplain Robert Carter provided the Invocation
- President Scott Shrader offered up a two minute Welcome to all those who called into the Zoom Meeting and did a quick introduction of Past President Bob Stanek
- Past President Bob Stanek conducted a quick 10-minute discussion by briefly introducing all of the 2019-2021 Board Members. He followed with a single slide talking about the status of the transition to the public charity. This included changes to the Constitution *(see note below)*, the By-Laws, Vision & Mission Statements, and a couple questions/answer session on the transition. Finally he ended with a brief explanation of the site accepting donations and the location of the "Donation Accepted" on the Association website.
- The Guest Speaker MG Matt Baker, the new commander for the 416<sup>th</sup> Theater Engineer Command, talked for 20-minutes on the "State of The TEC" with focus on five specific areas:
  - Current State of the TEC (Mission and Organization)
  - Higher Vision Guidance (USARC/FORSOM)
  - Impact of COVID-19 to the organization
  - Challenges ahead for the TEC
  - MG Baker's Vision for the next three years

Q&A with MG Baker for 10 minutes

Moderator Edgar offered up the results of the polls conducted, as well as a request for member participation in the new committees to be developed in the upcoming year, with a final explanation of the three 30-minute Breakout Sessions

Overall, in my opinion, the Zoom Annual Meeting went off as planned with only a few minor production errors and a couple time hacks missed. The unofficial total head count was thirty-eight participants in the meeting (including all 15 board members if I remember right) with at least six general officers participating in the call. The board had not specified a goal of how many people would participate, so any results was considered acceptable given the quick turn-over of this event from an actual Annual Dinner Meal/Meeting. Plus the breakout sessions turned out to be a huge success as many individuals noted the ability to talk with old friends. So the Board has agreed to do open up all monthly board meeting with a 15-30 minute breakout session after ever board meeting in the future if time permits.

1) First topic deals with the two approved changes to the ENCOM Association constitution as noted previously above. I wish you and your families a MERRY CHRISTMAS AND THE REST OF THE HOLIDAY SEASON celebrating COVID 19 free, with care and safety.



### DONATIONS TO THE ASSOCIATION ARE NOW TAX DEDUCTABLE

As many of you are aware, the 416<sup>th</sup> ENCOM Association, having amended our Constitution this past spring, has applied for recognition as a tax-exempt public charity by the IRS. Consequently, donations made to the Association are now, within limits established by the IRS, eligible for treatment as a tax deduction.

What you may not be aware of is that COL (Ret.) Dewayne Nelson has made, in addition to a \$500 donation, a pledge to match the next \$500 donated before the end of the year. So, if you were considering donating to the association, now (before the end of the year) would be a great opportunity to take advantage of these matching funds and effectively double your gift. Donations can be made directly online at our website, or by sending a check postmarked on or before December 31, 2020, which are considered made in 2020, to:



### **CHARITABLE GIVING AND THE CARES ACT**

On March 27, 2020, the Coronavirus Aid Relief, and Economic Security (CARES) Act was enacted. The largest economic stimulus package in U.S. history, the CARES Act allocates more than \$2 trillion to assist health care providers, businesses, nonprofits, and individuals who have been affected by the pandemic. I have listed here some provisions affecting charitable giving that you should know about as the end of the calendar year approaches:

- <u>Higher Charitable Deduction Limits</u>: In 2020 only, the annual limit on charitable deductions for cash gifts has been increased from 60 percent to 100 percent of adjusted gross income (AGI). This increases benefits donors and charities during a time of increased need for immediate cash giving. This may be of particular interest to donors who would like to make large gifts from retirement plans or who are looking to offset higher income or liquidity events in 2020.
- <u>Additional \$300 Charitable Deduction</u>: For taxpayers who do not itemize, but instead take a standard deduction, the Act provides for an "above-the-line" charitable deduction of up to \$300 for cash gifts. This provides a tax benefit for donors making smaller cash gifts that would not otherwise receive a tax benefit.
- <u>RMDS Waived</u>: Individuals must begin taking required minimum distributions from retirement plans beginning at age 72. That requirement has been waived for 2020. This allows retirees to keep those funds invested this year if they want. Note that donors may still make qualified charitable distributions (QCDs), which remain an easy way to make gifts directly to charity without realizing any income tax.
