John asked about the new slate of officers for the 2023 - 2025 Years. Eric stated that all the officers are in place for the next 2 years, but the position of "President-Elect" is not yet filled. We are currently looking for someone to step up.

Lee brought up to John Gessner, is there a place on the agenda for the presentation of the Certificate and the Replica Brick that will be displayed at the US Army Museum in Virginia? John stated that he had presented all the info needed currently. He dropped off indicating that he had another meeting to attend.

It is with great sadness that I announce the death of Master Sergeant (Retired) Norman Sabah who passed away on 30 July 2023.

MSG Sabah died from complications of Parkinson's disease. Norman and his wife Ezra moved to Istanbul, Turkey two years ago. He joined the Army Reserve in 1957 and retired in 1999 at the age of 60. MSG Sabah was assigned to the 416<sup>th</sup> ENCOM from the early 1990s until his retirement in June 1999. He was the staff chemical NCO for the ENCOM and a member of the 416<sup>th</sup> ENCOM association for over 20 years. MSG Sabah is survived by his wife Esra Sabah. MSG Sabah was 84 years old. Our Association President, COL (Retired) Robert Chevas and his wife flew to Istanbul and attended his funeral and burial on 31 July 2023.

Robert stated that he would circle back to the financials with Edgar. He stated that we had a substantial amount of funds. He is currently trying to put everything together.

Next on the agenda is membership with Ed. He stated that he had scrubbed everything. Ed stated that he contacted everyone by text, e-mail; voice mail; or spoke to them on the phone. He sent to Shaun a list of people that he had contacted, which was about 80% of membership. Knute states that only 1 had been up for a 2-Year membership then John interjected those 18 members had a 2-Year membership up for renewal there is 20 altogether. Knute asked the board if we should send out an e-mail for membership request then another one at 30-day reminder. John said currently we have the e-mail request 30 days out then at 15 days out is another e-mail; "That was nice about the new system that it already kicks out the reminder notice". I stated that I had a conversation with John Erickson who had called me about 2 or 3 weeks ago. I told him that I had paid \$100 dollars for a lifetime membership.

Lee interjected that since we're talking about the plaque for the Museum if you had talked to Mr. Murphy at the TEC to make sure they were agreeable about the plaque for the US Army Museum to

work with them on agreeing on raising the money for the plaque, because it would be a joint plaque. We will have to work with the TEC and ENCOM together to make sure all concerns are covered. Is there a reason to raise \$10,000 for 2 plaques then Robert stated "no.

We must consider that going through my e-mails I say we have about \$1,500 Dollars already saved up for the plaque. I interjected, "I have donated \$250.00 for the plaque" Lee said thanks Chip. Lee also said that from the July Ad-Hoc meeting it was determined that we'll have a separate line for the donations received for the plaque. Once you have determined that the TEC is onboard, we should get with Knute and see what kind of design we would like on the plaque. Lee asked Knute if he was willing to take on the task of designing the plaque, since you did the coin, are you willing to design our plaque for the TEC & ENCOM? Knute agreed that he would design the plaque. Eric said it would be a good idea to make the plaque for the 416 ENCOM rather than the TEC, can we see the ones that are out there, when you're talking about the ENCOM Association versus the 416th itself, many of those plaques out there are donated by other groups for the units that were out there. That's the way they are associated. I would encourage us to do it the same way. It's for the 416th but it's from the 416th ENCOM Association. There are good examples for us to do that. Lee stated that he has an example and the requirements for the plaque that he has downloaded, and he will e-mail Knute all the information. Lee also said that he took a couple of pictures of the plaques when we were at the museum in May.

Robert said he will contact the TEC to see who's going to the dinner. Knute stated that for those who did not buys any coins,..... the everyone chimed in that they would like some coins so I will bring them to the November dinner.

The one thing that came out after the agenda was the recovery phone number for the website, I believe John Erickson mentioned in his e-mail to me that it should be changed to Eric Larson. John said it was for the Gmail account. Eric does see a problem since it switches over every 2 years.

Lee said we had been toying with the idea of what to do with the funds we have accumulated. Due the objections with the legal eagles at the TEC, we ran into some roadblocks for our original ideas to be helping out our soldiers in need so one of our alternatives we had at the July Ad-Hoc meeting, Eric suggested that we could offer scholarships. I came up with the idea that we could contact the Scholarship Program leader with my veterans organization the 11<sup>th</sup> Armor Cavalry, his name is Mike Rafferty and I wrote an e-mail to him. He was nice enough to call me late this week. We had a nice discussion. They are a much larger organization than what we have, they usually give out 50 scholarships a year at about \$3,000 apiece. Their scholarships are offered to children, and as the 11 Cav Veterans are aging out, they now offer them to grandchildren as well. The first year they did that they had 160 applications. Then you must decide who gets it. I think we should be talking about just \$250 as we had originally discussed. Do we open this to children of members of the TEC or even the grandchildren? If that's the case, we must determine the criteria for the scholarships.

Maybe we could approach one of the high schools near the TEC who are the target recipients as a step in this process, and of course if the TEC is agreeable with us doing this. Are the any legal problems with this approach? Robert stated that his VFW worked thru the high schools in the area near Western Springs and LaGrange, Illinois they would submit them to their counselors, the high school would select the winner and they would have to submit an essay or report then we would give them the check.

Eric chimed in, I think we need to draft something, with all the challenges, rather than decide how we are going to give it out. We can engage another group and get that to the TEC Attorneys to see if they are accepting of this approach. The biggest thing is that the financial stuff could impact their security clearances which we need to take into consideration. This might have an impact. The Scholarship could

be subjected to your application stating why should you get it we could put some type of criteria in there and pose that to the TEC then we could pick the number and the amount we can give per year. Then we could decide at the beginning of the year. There are a few categories like the service member, spouse, children and even grandchildren. This could apply to current or former members of the TEC. We could open that as much as we wanted to try and support as many people as we can that are looking for that on how that criteria could be. I reported there are 3 high schools in the area near the ECNCOM (Hinsdale South High School, Darien – Westmont High School, Westmont, IL and Bolingbrook High School, Bolingbrook, IL) also I stated I think all of them have ROTC Programs. Ed agreed, let's look at a ROTC students. We need to keep the target program.

We should initially target the 416<sup>th</sup> Personnel. And we wait to see what the 416<sup>th</sup> Legal Eagle has to say about our new proposal.

Where are we on the next newsletter, do we have a deadline for the publication on the next newsletter, Michele stated not that I am aware of, I will probably need the rest of August to get it done and aim for September. It was stated by Lee that it should be done by 15 September then Rober chimed in that would be a good date since our next meeting is 9<sup>th</sup> of September.


John Erickson stated that the renewal fee for the **website** is coming at the end of September for the next 2 years will be increasing to \$1,530.00, that's an expense you need to think about.

## PACT Act Filing Deadline for Back Dated Benefits is 9 August 2023

This message is intended for all members of the 416<sup>th</sup> ENCOM Association who are veterans of the Korean War, the War in Vietnam, the First Gulf War (Operations DS/DS), or the War on Terror with deployments to Iraq and Afghanistan. The newly enacted PACT Act expands VA benefits for those who served in these conflicts. Even if you are already drawing VA benefits, the PACT Act expands the list of health conditions that are presumed to have caused these conditions.

While a VA claim for benefits due to a health condition covered by the PACT Act can be made at any time in the future, there is a special deadline approaching for all veterans. If you begin the claim process by filing for VA benefits by 9 August 2023, your claim will be back dated to 10 August 2022. This means that if your claim is approved, your benefits will have assumed to have begun on 10 August 2022. You will receive back benefits paid from the date your claim is approved to 10 August 2022.
